

## Contract and Waiver for Machu Picchu, Peru Yoga Retreat July 1-10, 2024

**Cancellation Policy:** If Participant cancels before March 1, 2024, Participant receives a refund minus the non-refundable deposit of \$1000.00 paid to reserve the room. If Participant cancels before April 29, 202, 60 days prior to the trip, they are entitled to a 50% refund of the total balance paid in excess of \$1000.00. Within 60 days or less of the trip, payments are non-refundable as the resort does not refund room reservations, train tickets, or entrance fees to Machu Picchu during this peak season. The Sponsor advises each participant to purchase personal travel insurance.
